**COOPERATION AGREEMENT BETWEEN MEGATREND UNIVERSITY OF  
APPLIED SCIENCES AND INSTITUTE OF EUROPE RUSSIAN ACADEMY  
OF SCIENCE (RAS) MOSCOW**

**THE TWO SIDES AGREE:**

1. *That it is of mutual interest and benefit for both Institutions to conduct certain actions which lead to the constitution of mutual cooperation, with the aim of realizing significant contribution to the development of appropriate curriculum and scientific programs of both institutions as well as the general contribution.*
2. *In the same manner, both sides have interest in making official mutual scientific exchange and cooperation, especially in the areas of research and teaching, according to the confirmed priorities.*

**AND WILLINGLY SIGN THE FOLLOWING DOCUMENT**

**First**

*Megatrend University of Applied Sciences and Institute for Europe RAS are obliged to combine efforts with the aim of expanding their scientific and technical cooperation.*

**Second**

*The cooperation between the two institutions will be realized in the following manner:*

- a) *Visits of academic representatives of Megatrend University of applied Sciences to Institute of Europe RAS, or vice versa, at different times of the academic year and in accordance with the planned program which will be directed towards the realization of the agreed mutual projects in the areas of reciprocal interest.*
- b) *Mutual activities and involvement of scientists and experts from both institutions, through counseling, courses, seminars, research projects and other activities.*
- c) *Providing help to both regular and graduate students in realizing activities at both institutions.*

*The realization of the above activities will be conducted under the national and other university regulations in power at the University, Institute at which the activity is realized.*

### **Third**

*This agreement does not require the costs of financing by either side, except in the mutually agreed cases.*

### **Fourth**

*Organizational, financial **and other** questions related to all forms of co-operation ensuing from this Agreement will be settled either on the basis of a programme of co-operation between the members of University/Institute or by an annex or memorandum to this Agreement or in some other suitable way.*

### **Fifth**

*This is a two-year agreement and will be automatically extended for the same period, except in the case of cancellation of the agreement in which case the written announcement from one party to another with at least three months notice is needed. Mutual papers or projects in procedure at the time of cancellation will be finished in the agreed manner.*

*This agreement will be valid from the day of signing by **the** appointed representatives from both institutions.*

*The agreement will be signed in four identical copies in English, therefore both parties are entitled to two (2) copies.*
